Should the ROCC be unavailable, the appropriate Area OC should be called. Finally, if the ROCC or Area OC are not available, the CO, Cdr McHale, is to be contacted directly at 250-213-5881.

083/22 – ADULT SCREENING REQUIRING UPDATE

Refs: A. NDSOD Standard 4B Individual Security Screening
B. CJCR Gp O 5010-1, Adult Screening
C. CJCR Gp O 5530-1, Civilian Instructor Management

IAW refs A through C, all COATS members, Civilian Instructors (CIs) and Volunteers (collectively referred to as adults) are required to maintain valid screening requirements in order to be eligible for service, employment or voluntary service. Any COATS member who fails to maintain valid screening requirements will be directed to cease parading. Any CI or Volunteer who fails to maintain valid screening requirements will have their employment / volunteer status terminated.

All adults are required to complete a Full Screening as defined in ref B upon initial entry into the organization. A Full Screening is valid for up to 5 years and the end date will align with the renewal date of the required screening component as outlined below, whichever comes earlier:

- a. **Police Records Check/Vulnerable Sector Screening (PRC/VSS)**: The PRC/VSS is valid for 5 years from the date of completion. To initiate the renewal process, all adults must submit an updated, original, hard copy PRC/VSS to the RCSU J1 Staffing section prior to the expiry date of their current PRC/VSS. Personnel are advised that completion of a PRC/VSS can take up to three months, therefore it is important that the process be initiated well in advance of the expiry date; and
 - b. **Reliability Screening (RS)**: COATS members and CIs require an RS. The RS is valid for 10 years from the date of completion. To initiate an RS renewal, COATS members and CIs are to submit a completed Cdt #172 form, along with the required certified copies of identification and proof of address, in hard copy, to the RCSU J1 Staffing section prior to the expiry date of their current RS.
3. Annex A provides a list of personnel whose PRC/VSS and/or RS will require renewal, personnel who have extended beyond the validity period of their screening and have been directed to cease parading, and personnel whose screening has been approved.

085/22 – SCREENING FOR NEW ADULT VOLUNTEERS

Refs: A. CJCR Gp Order 5010-0, Adult Screening
B. CANCDTGEN 016/21, Transition of Screening for Existing Volunteers
C. Transition Plan: CJCR Gp Order 5010-0, Adult Screening, 3 June 2021
D. Adult Screening Toolkit

IAW ref A, CJCR has assumed responsibility for screening all adults who will or may have direct contact with a cadet. Once it has been identified that an adult will require a CJCR screening, the Adult Screening Process will be initiated using Annex A to ref A. CJCR Gp Order 5010, *Adult Screening*.

Corps/sqn COs support recruiting and initiate screening. New applicants will complete the Adult Screening Application form, Annex A of ref A. Corps/sqn COs will review the application and arrange for an interview. The corps/sqn CO will coordinate and complete an Initial Interview using the Interview Statement at Annex A and Interview Template at Annex B of ref D, *Adult Screening Toolkit*. The purpose of the interview is to discuss the rights and obligations with the adult, as well as determine the screening requirements before moving forward in the process. There are two levels of screenings to consider:

BASIC Screening: The minimum screening level required for any adult who supports the Cadet Program on an occasional basis and will not be under the constant supervision of a fully screened adult. This may apply to committee members, occasional community supporters, occasional drivers, League members and guest lecturers. It may apply to CAF Reg F and P Res members, DND employees and civilian contractors in accordance with their type of engagement; and

FULL Screening: The screening level required for any adult who has direct and unsupervised contact with a cadet or where direct unsupervised contact is probable, as well as all COATS members, CIs and volunteers. This may apply to CAF Reg F and P Res members, DND employees and civilian contractors in accordance with their type of engagement.

For BASIC screenings, reference checks are optional and may be conducted by the corps/sqn COs at their discretion using Annex C of ref D. For FULL screenings, corps/sqn COs will submit the complete application package with applicable notes to RCSU J1 who will contact references as provided on the application form. RCSU will retain the application package for record keeping.

The original PRC/VSS will be given by the applicant to the corps/sqn CO who will forward it to RCSU J1 with the application package. The discovery of adverse information during police checks will automatically initiate a detailed review of the applicant/member's file by RCSU. It is important to note that not all cases will lead to a finding of unsuitability or termination.

Once steps 1 through 4 are completed, as outlined in ref D, the corps/sqn CO may review and approve any BASIC screening. Following a BASIC screening's outcome, the corps/sqn CO will forward the application with all applicable notes to RCSU J1 for final review and record keeping. A complete application package will include the following:

Annex A - Adult Screening Application form;
Certified true copies of the front and back of two pieces of government issued ID;
Original hardcopy of a valid PRC/VSS;
Adult Screening Toolkit Annex D – Adult Screening Interview Questions; and
(When applicable for BASIC screenings) completed reference checks.

Following completion of the adult's screening, RCSU J1 will provide the applicant and the corps/sqn CO with an authorization letter that details the screening level and expiration date. IAW ref A, no adult will be employed or engaged in cadet activities until the appropriate screening is completed.

086/22 – CIVILIAN INSTRUCTOR AGREEMENT REQUIRING UPDATE

Ref: CJCR Gp O 5530-1, Civilian Instructor Management

1. IAW with ref, Civilian Instructors (CIs) are required to sign an employment agreement for a specific period and/or activity. The maximum length of time for which a Regional Employment Agreement may be in force for employment at a corps/squadron or cadet training site is five years and will not be longer than the screening validity period. An Employment Agreement will terminate on the date indicated in the agreement unless terminated voluntarily by the CI or for cause by the RCSU CO.
2. Annex B provides a list of CIs whose employment agreement and / or screening will be expiring in the near future. CIs who have extended beyond the validity period of their employment agreement are directed to cease parading until a new employment agreement and screening has been approved.

087/22 – RANGE SAFETY OFFICER (AIR RIFLE) CERTIFICATIONS

1. RSO (AR) certifications are considered non-expiring per CATO 24-14 Annex A, as such, any member who has completed the course is still considered qualified to run an Air Rifle range. Per directions from COATS NTE, newly certified RSOs will have their name published in the Routine Orders as a verification that their course completion has been received by RCSU. To begin this process, we are attaching at Annex B the current list of all members in the region who show a completed RSO (AR) course on their personnel file. Future RO entries will only show newly completed certifications.

088/22 – EXTENDED SPECIALITY CERTIFICATION RENEWALS

1. The pause in COATS training due to the pandemic continues to affect the ability for members to maintain and renew speciality certifications. Given that regions may have had limited opportunity to conduct recertification activities since the return to in-person training, specialty certifications that have expired since 1 March 2020 will be further extended until 31 October 2022 to allow for appropriate recertification activities to occur.

2. The certifications affected include:

- a. Range Safety Officer Large Bore (RSO[LB]),
- b. Range Safety Officer Biathlon (RSO[B])
- c. Flat Water Canoe Instructor (FWCI),
- d. Moving Water Canoe Instructor (MWCI),
- e. Mountain Bike Instructor (MBI), and
- f. Abseil Instructor (AI).

3. CANSail Instructor qualifications will follow the guidelines released by Sail Canada and first aid qualification will follow the guidelines from St. John Ambulance.

4. As it relates to the maintenance of COATS training certifications, all current FORCE Evaluations or those that have lapsed since 1 March 2020 are also considered to be extended until 31 October 2022. FORCE evaluations are to be completed promptly once the testing resumes.

089/22 – OUTCAN LEAVE REQUESTS

1. All OUTCAN leave requests (CF 100) shall additionally include an email to their supervisor when submitting the Monitor Mass (MM) Leave Pass (CF 100) request. The email will contain:

- a. the member's safety plan WRT the latest CDS Directive on COVID-19;
- b. both Travel and Contact Security (TCS) Assessment and TCS Debrief for each country travelled through in addition to the destination country; and
- c. the member's mitigation plan for any risks identified within the reports created at sub-para b above.

2. With the exception of the USA, every member is required to complete a NOI to Travel result which is automatically generated within MM. When the CF 100 is drafted, it is returned to the member within a couple of days and then forwarded to that member's supervisor.

3. Members must ensure that all countries they are travelling through are listed within MM during their initial CF 100 draft creation. For example, when flying to Vienna with a short layover in Frankfurt, a member will include both Germany and Austria on the CF 100 request.


